In response to the recent FBI recommendation that local law enforcement agencies preserve the records of guns that are seized or forfeited, Virginia attorney general Mark Herring (D) issued a statement Tuesday supporting efforts to retain these records and make them more accessible. He added that existing federal gun laws prevent the seizure of such records and that local efforts to create their own laws to keep this information will not be attempted. "It is important that local jurisdictions be able to retain records of guns seized and forfeited in connection with criminal investigations," he said. "Furthermore, I do not believe that current federal law makes it possible for local jurisdictions to take property based on possession of a firearm that has been seized as part of a criminal investigation. Virginia's local law enforcement agencies use these records to fight crime and prosecute criminals. This has been done effectively c6a93da74d
